Consultation and Lodging Submissions

Council is currently undertaking community consultation to inform the community and stakeholders about the draft Central Coast Local Environmental Plan (CCLEP) and draft Central Coast Development Control Plan (CCDCP). Details of community information sessions to be held and how information can be obtained are outlined below.

What is on exhibition?

Council has a range of material on exhibition for public review and comment from 6 December 2018 until 28 February 2019. These include:

- draft Central Coast Local Environmental Plan (CCLEP) and associated supporting documentation
- draft Central Coast Development Control Plan (CCDCP) and supporting documentation

All submissions should state whether it relates to the draft CCLEP or draft CCDCP and state particular references such as clause numbers or property address and/title (Lot/DP). You are also encouraged to indicate your reasons if you are objecting to particular aspects of these documents.

Submissions should therefore not include references of a personal nature.
