

# Local Character Statements Toukley Social Planning District

## **CONSULTATION REPORT**

## 1. Executive summary

Central Coast Council (Council) is working to prepare a series of Character Statements for the Toukley Social Planning District which includes Toukley, Canton Beach, Noraville and Norah Head. These will be in accordance with NSW Government guidelines issued by the Department of Planning and Environment.

To achieve this, Council undertook a stakeholder consultation program to obtain community input about what people value in the local area, what they want to see maintained or enhanced into the future, and what they would like to see changed.

Consultation ran from 6 December 2021 to 25 February 2022. It was widely promoted through local media, social media, flyers and other networks, and included a major survey and a series of focus groups. The survey was made available:

- online through Council's Your Voice Our Coast web page
- in printed form at local clubs, retail outlets and other venues
- via email links and phone calls to Council contacts and community networks
- in person via street walks at Toukley and Norah Head

Three focus groups were held after the survey closed and these generated further discussion about local character. They were held in-person and online, with one group involving Council staff who had a personal or professional interest in the area.

#### What we heard

Council received a total of 378 survey responses from a broad cross section of community members including people of different ages, backgrounds and interests.

The survey results showed some common themes running through all four suburbs. These indicated that key contributors to local character were lakeside or coastal living, green space and natural features, water views, village atmosphere, low-scale development, and a relaxed and recreational lifestyle.

The focus groups then discussed these issues in more detail and highlighted the importance of preserving local views and low scale development, and opportunities to highlight local indigenous and European heritage. Participants also identified the need to upgrade Toukley town centre, the potential for more retail and residential development at Canton Beach, the value of Norah Head Lighthouse and beach areas, and the need to upgrade parks and walkways through Noraville.

## **Next steps**

Council will review all consultation feedback and use it to prepare a series of draft character statements for each of the four suburbs. These will then be publicly exhibited for further community feedback before they are finalised.

Once adopted by Council, the local character statements will inform the area's strategic planning directions and development controls as it continues to grow and evolve.

## 2. Introduction

## 2.1 Background

The Toukley Social Planning District is within the northern area of the Central Coast local government area and incudes the suburbs of Toukley, Canton Beach, Noraville and Norah Head. It has unique characteristics that are important to the local community, including its natural, urban and social environments.

Many local communities want the local character of their area to be given greater consideration in future planning decisions. The NSW Government has therefore issued a series of guidelines for local councils to consult local communities and identify local character.

In line with these government guidelines, Council conducted a community consultation program to obtain feedback on what people value about their area, what they would like to see maintained or enhanced, and what they would like to see changed.

The feedback received will be incorporated into formal 'Character Statements' for the area and, once adopted by Council, will help to inform future planning decisions. This will be an important process for the Toukley Social Planning District as the area continues to grow and evolve.

## 2.2 Preparing local Character Statements

Council is due to prepare a series of local Character Statements for the Toukley Social Planning District. Once adopted, the Character Statements will inform and guide local planning decisions as the area continues to grow.

Local character is a combination of the social, environmental and economic features of an area. It includes the natural landscape, sense of community, built environment, connectivity, recreation areas, employment opportunities, history and culture, and other related issues.

A consultation program was undertaken to obtain community feedback on how people see the unique character of these suburbs. This feedback will help to ensure the new Character Statements reflect community views.

The consultation process was in line with the NSW Government's "Local Character and Place Guideline" published in February 2019. The Guideline states:

"The effectiveness of the planning system relies on collaboration with and input from community so that outcomes suit the needs of the people it is planning for. The active players that interact with the planning system and shape local character include the community, local government, private enterprise and the NSW Government."



## 3. Engagement approach

## 3.1 Purpose of engagement

The purpose of this engagement program was to consult the local community about what they value in the local area and what they want to see maintained or enhanced in the future.

By including the community in the initial stages of the work, it ensured their views and values are captured in the new Character Statements that will be adopted by Council. This means that community views will help to inform development planning and assessments going forward.

This project was an opportunity for the community to offer their input into the current and future character of their local area as it continues to develop and evolve. The engagement process encouraged all community members to participate in the process, regardless of age, gender, physical ability, socio-economic status, sexuality or cultural background.

The purpose of engagement was to:

- Consult people who live, work and play in the local area including local residents, businesses, schools, clubs and other organisations
- Seek input from people on what they value in the local area
- Identify what the community wants to see maintained or enhanced in the future
- Provide an opportunity for people to have their say on the current and future character of their local area
- Enable the new character statements to reflect community views

## 3.2 Our engagement framework

Consultation has been designed in accordance with Central Coast Council's Engagement Framework. ## 3.3 How we consulted

Council conducted a comprehensive engagement program from 6 December 2021 to 25 February 2022. This included a mix of digital and face-to-face engagement activities to encourage a broad cross-section of community responses, including participation of people from different ages and backgrounds and with different local interests.

Consultation activities included printed, online and face-to-face surveys to gain initial feedback on how people value their local area. This included both quantitative and qualitative questions to obtain community insights about each suburb.



Topline survey responses were then compiled and presented to three focus groups for further discussion. These were held in-person and online to accommodate local attendance. All activities complied with NSW Public Health Orders and Covid-19 safety requirements.

The consultation process (survey and focus groups) was promoted using a range of direct and online channels, including a media release, social media posts, letterbox drop and EDM, as well as a series of phone calls and emails to local schools, businesses, clubs and other organisations. All promotional collateral is included in **Appendix A**.

## Focus groups

After the online survey closed, 3 focus groups were held inperson and online by independent facilitators to discuss survey feedback and capture additional ideas.

Community members could register their interest through a dedicated email listed on the Your Voice Our Coast webpage and through discussions with team members during stakeholder phone calls and street surveys.

Focus groups were held on:

- 21 February 2022, 2pm-4pm, Toukley Community Hall and attended by 9 community members and 3 Council staff members
- 23 February 2022, 10am-12pm, Online via Zoom and attended by 14 Council staff members
- 23 February 2022, 5pm-7pm, Online via Zoom and attended by 7 community members and 3 Council staff members

One community member who attended the 21 February focus group was unable to stay for the full session and later emailed some comments through. These have been incorporated into the focus group discussion notes.

## 4. What we heard

Council sought feedback from the community between 6 December 2021 and 25 February 2022.

Engagement resulted in the following:

- 1,003 visitors to the Your Voice Our Coast website
- 268 social media post engagements (comments, reactions and shares), plus 351 post clicks
- 378 people logged in to the online survey although 105 did not answer any questions
- 273 people responded to the survey questions (online, printed and face-to-face), including 228 answering questions for Toukley, 119 for Canton Beach, 94 for Noraville and 104 for Norah Head
- 36 people attended focus groups including Council staff
- 1 email received with feedback as the person could not stay for a full focus groups

### Who we heard from:

People who responded to the survey and attended the focus groups came from a broad cross-section of the community, including different ages, interests and suburb locations.

More details about the demographics of survey respondents can be found in Appendix B.



## 4.1 Method 1 – Community survey

A comprehensive survey was made available between 6 December 2021 and 9 February 2022. This included printed copies at local clubs, retail outlets and other venues, online access through the dedicated Your Voice Our Coast webpage, emailed surveys to local community groups and networks, and face-to-face surveys via street walks in Toukley and Norah Head.

The survey asked quantitative and qualitative questions for each suburb, including how to describe the existing character of your suburb, what makes your suburb unique, social and economic features of the area, important environmental features and what you would like to see changed, retained or improved.


Topline survey results indicated a number of common themes and key contributors to local character:

- Lakeside or coastal living
- Open green space and natural features
- Water views
- Village atmosphere and low-scale development
- Relaxed and recreational lifestyle

More specifically, the results showed the following:




## **Toukley:**



- The scale of development and larger lot sizes help make it a unique and relaxing coastal village and holiday experience that's different from the city. 'Limit density especially multi-storey apartments'.
- Various public spaces, community facilities (e.g. library, swimming pool) and recreation
  opportunities contribute to a vibrant, connected community and make it good for
  families. 'The Village Green is important for community events'.
- Trees, bushland and access to natural environment make it a pleasant living and holiday experience.
- Toukley village feels tired and has lost its character. It has potential but needs to be updated.
- More variety needed in the town centre, new retail boutiques, nicer dining and bars.




### **Canton Beach:**



- Local parks, recreation opportunities and the lake foreshore provide lots of recreation that's close to home - good for families and older people. 'Great place for family recreational activities.'
- Lot sizes, scale and setbacks around buildings contribute to relaxed, spacious beachside feel.
- Tidy up or replace old houses, buildings and vacant lots.
- Improve maintenance along foreshore and clean up the weeds on beach and lake. 'The lake front path is such a wonderful walking area'.
- Retain parks, green spaces, recreation areas, playgrounds, foreshore picnic facilities, seating, pathways, cycleways and exercise equipment.




### **Noraville:**



- Trees, parks and green areas contribute to the character of Noraville. 'I value all the natural beauty'.
- Nice community feel and family environment. 'It has a feel of a country coastal village'.
- More cycle ways and footpaths for walking and cycling.
- Improvement in road safety needed upgrading the roads, pedestrian crossings, installing speed humps and cameras.
- Keep lot sizes as they are, low density housing and no new developments or high rises.



## **Norah Head:**



- Retain scale and don't over-develop, no unit blocks, 'don't turn it into Manly or Terrigal'.
- Swimming and local beaches contribute to the character of Norah Head.
- More coastal walkways, including a path joining all the beaches and access to Toukley.
- More barbeques, picnic facilities and shade areas.
- Protect existing vegetation and plant more trees.
- 'Keep it a relaxed environment' and 'keep it as natural as possible'.



## 4.2 Method 2 – Focus groups

A series of focus groups were held on 21 and 23 February 2022 to generate more detailed discussions about the characters of Toukley, Canton Beach, Noraville and Norah Head. These included:

- 9 community members and 3 Council staff at an in-person focus group on Monday afternoon, 21 February, at Toukley Community Hall
- 14 Council staff in an online focus group on Wednesday morning, 23 February, via Zoom, and
- 7 community members and 3 Council staff in an online focus group on Wednesday evening, 23 February, via Zoom.

All focus groups were coordinated and run by independent facilitators to ensure open and balanced discussions. Participants were presented with information about what constitutes character statements, the consultation process so far, and topline results from the recent survey. They were then encouraged to discuss a number of key topics for each suburb, including:

- Views and natural features
- Culture and heritage
- Community feel and accessibility
- Scale of residential housing and street trees
- Town and village centres
- Potential new developments

Key comments received from the focus groups included the need to preserve local views and access to the natural environment, greater recognition of local history and heritage, a desire to maintain low-scale residential development styles, and acknowledging the potential for more retail and business opportunities.

Participants identified the need to upgrade Toukley town centre, the potential for more retail and residential development at Canton Beach, the importance of Norah Head Lighthouse and beach areas, and the need to upgrade parks and walkways through Noraville.

It was acknowledged that each suburb is intrinsically different and their unique characteristics should be protected. People also said there should not be change for change-sake and that the Central Coast should not try to be like Sydney or Newcastle.

Key points of discussion are summarised below:

### **Toukley**

• People value the local views of the lakes, beach and national park and wanted these to be maintained and protected. Views from Toukley Bridge were seen as important as people drive into town.



- Consideration should be given to a good entry statement. The current suburb entry when crossing Toukley Bridge is a half constructed derelict building which doesn't give a good impression.
- Opportunities should be explored where views down streets should extend to the lake to provide a clearer link to place.
- Access and connectivity to the lake, beach and national parks are important and could be enhanced. The lake itself needs cleaning up.
- People could be encouraged to understand and value their natural surroundings more.
- The precinct is bounded by water which is intrinsic to its character. We need to maintain the awareness of the water and natural environment throughout the whole precinct as redevelopment occurs.
- We could highlight the views to Mount Yengo and the Watagan Mountains from points within the town centre.
- Indigenous cultural connections to Toukley should be better highlighted. Historic and heritage buildings should be protected.
- Pedestrian friendly streets are starting to come, although some areas still have no footpaths. There's a need to review the walkability and bike access between the town centre and the bridge.
- New development should contribute to pedestrian friendly streets, respect pedestrian scale and provide awnings.
- There is a good mix of housing styles with older homes adding to local character –
   "Many houses have been built through time."
- The 'Avenue' streets are straight and have character.
- People recognise the need to increase housing density to support more retail and dining options. However they did not want high rise developments as these would impact the 'feel of the area' and could cut off the views.
- People accept that development is inevitable but this needs to be sensitive to the local environment. 'Population growth is limited by environmental constraints.' We can't stop change, we just need to manage it.
- Population growth should be limited by the local infrastructure capability.
   Infrastructure hasn't kept up with the increasing density, eg dual occupancies and secondary dwellings. Traffic congestion has increased.
- Holmes Ave is an example of what the community does not want, while Hammond Rd is a good example of what the community would prefer.



- Taller buildings should be located on the ridge areas and then building heights could be stepped down towards the lake foreshores to maintain visual connections with the lakes.
- Tree-lined streets should be protected as they add to the local character. Council could encourage residents to plant native trees and vegetation.
- The corridor of original gum trees at the back of some houses contributes to the character. There is a danger of losing this as more development occurs.
- Toukley town centre is considered to look 'tired and outdated'. It needs a good shopping strip with a village feel with modern cafes, restaurants, retail options and bars that add character and attract visitors to the town. Active street frontages are important.
- There is a need to improve signage and wayfinding and connections to the lake.
- The emerging dining scene is good, and more cafes, bars and retail stores could be added to the main street.
- A consistent and unified theme could be introduced for local businesses and buildings to make it more appealing, eg like the Connectivity Project in Tuncurry.
- The Coles car park disconnects the town. It is too big and the space could be turned into a shopping area. However the town centre should not be overdeveloped as it is already congested. It should not become the next Terrigal or The Entrance.
- Toukley has a lot of potential and already has everything in terms of services, schools, shops and medical needs.
- Top-shop housing could add to the local atmosphere and also improve safety. The Toukley Markets should also come back.
- 'We are lucky to have the Village Green' although more activities could be held there and the playground could be upgraded. The artwork and murals are great. More signage would help people find the Village Green, especially when coming from Main Road.
- There is no visual or physical connection from Main Road to the Village Green. This should be explored if redevelopment occurs. Perhaps we could put lights in trees or paint the lower part of telegraph poles to draw people into the centre and onto the Village Green.
- 'It's all there, we just need to make the most of it.'
- 'Don't change for change's sake.' Stay true to the local character and embrace our area.



- Participants saw Long Jetty as a good example of town development with its flags, murals, public art and speciality food shops. Toukley could also be like Nelson Bay, Shoal Bay, Gerringong and Forster.
- Some new developments look better than others. It would be good if building
  materials reflected the local character and lakeside location. Different building
  materials can affect how things look. The new aged care facility is nice.
- Umina and Woy Woy were seen as good examples for residential developments.

#### **Canton Beach**

- Views of the foreshore, lake and ocean are important and exciting should be protected. The 'big sweep of the foreshore' is distinctive to the area's character.
- The public land around the foreshore is great. Extending the beach and updating other open space areas could encourage more recreational use.
- The quality of the lake needs to be improved and cleaned up so people could use it more.
- Trees and vegetation are important, as is access to the national park. It will be good to improve connectivity and natural walking trails here. Preserving the red gums is important.
- The foreshore is a safe place for homeless people who use it for shelter and cooking.
- The local fishing and migrant history could be better recognised, including Chinese connections which date back to the Gold Rush.
- The area is well used on weekends and has hosted community events of up to 5,000 people. The shared pathway is great and the sensory playground and exercise equipment are also well used.
- More signage would be good. There are currently no desire-lines or wayfinding to Canton Beach.
- Canton Beach is 'a hidden treasure' that not many people know about, other than locals.
- Lot sizes and the space around houses are important to the local character and allow room for vegetation. The existing low-scale density and building heights should not change, although some of the streetscapes could be improved with more trees.
- The look and feel of community / affordable housing isn't great as they use lesser quality materials and less landscaping.
- Canton Beach has a different landscape character and is more relaxed than Toukley



- The area has huge potential with its holiday park, sailing club and other features.
  However the tourism zoning is restrictive as it creates empty lots which are neglected
  and vandalised. The zoning could change to allow more retail and residential
  developments which could help improve the area. Shop top housing could help
  enliven the area.
- The tourism zoning does make the area unique and should be capitalised on. The area should be developed as a tourist precinct.
- The area needs more cafes and restaurants but there is currently not enough customer base to support this. It could be good for waterside cafes and dining, some retail options, bars, nightlife and lakeside walkways. It could be like Brunswick Heads.
- While development potential is important, it should still leave space for vegetation.
- Canton Beach is not like Terrigal or The Entrance, which is good.

#### **Noraville**

- The 'sight lines to the lake are special', especially from the higher streets. The views of Hargraves Beach should be protected and better access to the beach would be good.
- This is a unique area where you can walk to the beach and the lake.
- There are lots of trees across the area and street trees add to the attraction. More trees could be planted, ideally natives which would connect and blend with the local bushland and national park.
- The Redgum Trail and access to the Wirrabalong National Park is a good secret for locals. It's also good to see the gums where Evans Road joins the National Park. The Redgum Trail and Wetland Trail should be joined.
- Local heritage elements could be highlighted more, such as Hargraves House and the cemetery. Cultural heritage is also important and should be highlighted more, including direct local links to Bungaree.
- This is a predominantly residential area which has a nice community and family feel. The two local schools and other facilities bring families and community members in.
- There is minimal open spaces for public gatherings. Irene Parade Reserve could be enhanced and better used. A large shelter, nature-based play space, more seating and other facilities would be good. Other local ovals could also be enhanced.
- While some pathways work well, more footpaths and cycleways would be good, including a link between Noraville and Canton Beach. More walking trails could also run through the bushland.
- Kerb and guttering is not the way to go for healthy lakes.



- People currently go to Toukley or Norah Head for recreation. There's nothing really for teenagers in Noraville.
- Noraville is a nice leafy area with generous lot sizes including quarter acre blocks from the 1970s which allows for vegetation. It features single-level old homes that add to the local character and are attractive for families.
- People recognise future development is inevitable to support the growing population and demand, but don't want the area overdeveloped with larger scale buildings.

  Some increased low-scale density could be okay (eg two-storey villas on large lots).
- There is some variety in real estate including older and smaller housing across the leafy centre and around the main road, with larger new builds in the 'ritzy' end along the beachfront which gives a different character.
- Streets are wide with good setbacks and plenty of opportunity to park. This gives a sense of space Even narrower roads appear wider because of the setbacks and it would be good to maintain this feel.
- Traffic calming measures could be installed along Evans Road and Oleander Street. Crossing Evans Road can be difficult.
- Council's done a good job of hiding the sewerage plant, although the smell is noticeable when the wind blows from the south or west.

### **Norah Head**

- Norah Head is 'an amazing place' which is surrounded by nature. It has great views of the ocean, beach, headland and bushland which need to be protected. Cabbage Tree Bay, the rockpool and sand dune are also highly valued.
- Views from retail strip to the water are important, as is the connection to the beach.
- Soldiers Beach is considered one of the best surf beaches in Australia. It is
  'internationally iconic' and should be treated like an icon with good public art and
  high-quality facilities. It is also a popular area for whale watching so a whale mural or
  sculpture here would be great.
- The area is surrounded by bushland so 'everything is a little hidden and part of the magic'. It has a 'sense of discovery' as you enter through the bushland. Walking through the national park and bushland is 'special'.
- The bushland areas need more protection and maintenance. Some of the coastal vegetation has strong ecological values. The mix of native and introduced trees (eg pines) add to the character of the area. The landscape is an extension of the national park.



- Norah Head Lighthouse has historical and cultural value. It provides a sense of local identity and should be flagged as a landmark. It wins awards for being the best photographic location for weddings and has also been used for local events.
- Views of and from the lighthouse are important and need to be protected, although there are not many places you can view the lighthouse from. Access for people with mobility issues could be improved and more parking is needed.
- The merchants and mariners' history is important to the area, including the shipwrecks out at sea. The ruins near the rockpool have a logging maritime history. It would be good to highlight all this better with more interpretative signage.
- Aboriginal history and indigenous cultural sites should be retained and recognised. It
  would be good to add more Aboriginal art and stories along the foreshore and in
  other recreation spaces. We should improve recognition of the traditional owners.
- 'We need a history centre at Norah Head.'
- Norah Head is the go-to beach and recreation focus for areas of the Central Coast and for visitors to the area although road access is limited with only a single road in and out.
- It a daytime destination but there is not much to do at night.
- There could be more footpaths, walking trails and cycle paths to improve connectivity, and also more wayfinding. Council should continue and expand the shared pathway and push forward with plans to upgrade Mazlin Reserve.
- Lots of families live in the area and there's a good sense of community ownership. 'People care about where they live.' The swim school also brings people into the area.
- 'There is a good mix of houses in the area, not just the same-same.' This adds to the local character as it makes it interesting and vibrant. Public space breaks up the monotony of residential lots.
- The tree canopy, greenery and bush nature is nice and should be maintained and reflected in any new developments. Maybe have some more street trees along the main road to provide shade and reduce the heat island effect.
- New developments should maintain the low-scale of the area, even if densities increase. They should be made of high quality materials that look good. New homes should not be allowed too close to the cliff edge.
- Development pressure elsewhere brings flow-on pressures to Norah Head. Increasing density could bring more people to Norah Head to support local businesses.
   Developers should be required to provide their own infrastructure (eg water and sewer connections) and provide off-street parking.



- The existing scale of the village centre is good and should be retained. People don't want high rise and don't want the area to become like Manly or Terrigal or The Entrance. Views from the shops add to the character.
- There is a good balance of cafes, restaurants and shops that support the locals and visitors. There is potential for a small increase in height and the number of shops but this should still keep in touch with the local character. More outdoor dining and shade might be good.
- The appearance of building facades could be improved.
- There are more opportunities for pedestrian activities around the village centre, including in the laneways.
- More accessible parking and more formal parking near the rockpool would be good.
- There are opportunities for shops near surf club.
- The Caravan Park is a great public space for the wider community.



## 5. Next steps

Thank you to everyone who took the time to participate in the community consultation process for the Toukley Social Planning District Character Statements.

The next steps for preparing the local character statements are below:

- Council will review feedback received to prepare draft local character statements for the area.
- These draft statements will be publicly exhibited for the community to provide further feedback, which will be analysed and help Council to finalise the local character statements before being put to Council for adoption.
- Residents, businesses and other stakeholders will be notified prior to the draft statements being made available for further comment.
- Once adopted by Council, the local character statements will inform the area's strategic planning directions and development controls to guide future development.




