## Closing The Loop Outdoor Trading Specification Community Engagement December 2023March 2024

## Summary

Between December 2023 and March 2024 Central Coast Council placed the Draft Outdoor Trading Specification on public exhibition to seek community feedback. Council held 3 community information sessions, two face-to-face (Wyong and Terrigal) and one online during the month of February 2024. Over 16,000 Central Coast Businesses were reached out to encourage feedback via EDM. During the public exhibition period 32 submissions were received.

## What we heard and how we responded

Table 1 below captures the themes of feedback received from the community on the Draft Outdoor Trading Specification and identifies how that feedback has been incorporated into the final documents, where appropriate.

Any service of alcohol within an Outdoor Trading Area is subject to obtaining Development consent and an appropriate liquor licence from the NSW Office of Liquor and Gaming. This requirement is identified within the Specification.			
Hygiene	Food businesses must comply with related regulations.	All Outdoor Trading Areas that handle food are required to comply with the Food Act 2003. This Act is listed as Relevant Legislation in the Specification.
